REFUND POLICY FOR TUITION FEE

A full tuition fee refund, less the administration fee (CAD\$500.00), will be granted if Citizenship and Immigration Canada does not issue the Study Permit. To obtain a refund, the student must provide:

1. **Copy of the Letter of Rejection from Citizenship and Immigration Canada**
2. **Copy of the Nile Academy Official Letter of Acceptance**
3. **Copy of the original receipt of tuition payment**
4. **A Refund Request Form from the parent/guardian including the name and address of the cheque recipient or wire transfer details**

There will be no refund of the tuition fee in the following circumstances:

- **if the student chooses to withdraw for reasons other than the Study Permit has been denied by Citizenship and Immigration Canada**
- **if the student is found in violation of Nile Academy policies and procedures**
- **if false or fraudulent information was given and/or not disclosed in the Student Application Form**

In the event that the student's immigration status changes during the school year, the parent/guardian of the student is to contact **the International Students and Admissions Office** immediately.

We fully understand the refund policy of Nile Academy. We understand that the Nile Academy shall not be held liable for losses or expenses as a result of the Board being unable to provide education owing to labour disputes or other causes beyond its control.

PARTICIPATION AGREEMENT

4. The student's educational information can be shared with parent/guardian, CIC custodian, Nile Academy school and central staff in order to provide the student with the necessary guidance and assistance for student success.
5. Any inaccuracies in the application or failure to abide by the above conditions may result in immediate dismissal from Nile Academy without refund of tuition fee.
